# AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

## FD-2005-00298

**GENERAL:** The applicant appeals for upgrade of discharge to honorable, to change the reason and authority for the discharge, and to change the reenlistment code.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

**FINDINGS**: Upgrade of discharge, change of reason and authority for discharge, and change of reenlistment code are denied.

The Board finds that neither the evidence of record nor that provided by the applicant substantiates an inequity or impropriety that would justify a change of discharge.

**ISSUE**: Applicant contends that he should not be penalized indefinitely for a mistake he made when young. The records indicated the applicant received an Article 15, two Letters of Reprimand, one Letter of Counseling, two Memorandums for Record, and six AETC Form 341s for misconduct. The misconduct included failure to go, late for duty and formation on divers occasions, failure to complete homework assignments, room inspection failure, and failure to meet minimum standards of correctional custody. The DRB opined that through these administrative actions, the applicant had ample opportunities to change his negative behavior. The DRB recognized the applicant was 19 years of age when the discharge took place. However, there is no evidence he was immature or did not know right from wrong. The Board concluded the misconduct was a significant departure from conduct expected of all military members. The characterization of the discharge received by the applicant was found to be appropriate.

**CONCLUSIONS:** The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

1. I am recommending your discharge from the United States Air Force for minor disciplinary infractions and unsatisfactory duty performance. The authority for this action is AFPD 36-32 and AFI 36-3208, Chapter 5, Section H, paragraph 5.49 and Section E, paragraph 5.26. If my recommendation is approved, your discharge will be described as honorable or general. I am recommending that your service be characterized as general.

2. My reasons for this action are:

a. In a letter dated 5 Dec 02, TSgt Correctional Custody Interim Superitendent, indicated you failed to meet the minimum standards of the correctional custody program, for which he and his staff recommended your discharge from the Air Force. (Atch 1, Appendix A w/atchs)

c. On or about 18 Oct 02, you were late, for the second time, to the Academic Enhancement program formation, as noted on AETC Form 341, dated 18 Oct 02. (Atch 1, Appendix C)

d. On or about 12 Oct 02, you were 1 hour late late for the Academic Enhancement program formation, as noted on AETC Form 341, dated 12 Oct 02. (Atch 1, Appendix D)

e. On 11 Sep 02, 16 Sep 02, and 30 Sep 02, you violated Article 92, UCMJ, by not doing your homework, for which you received a Letter of Reprimand, dated 4 Oct 02. (Atch 1, Appendix E)

f. On 30 Sep 02, you were counseled for unsatisfactory performance by failing to apply yourself in and out of the classroom, as noted on AETC Form 173, dated 30 Sep 02. (Atch 1, Appendix F)

g. On 16 Sep 02, you were counseled for unsatisfactory performance by failing to apply yourself when you are not in class, as noted on AETC Form 173, dated 16 Sep 02. (Atch 1, Appendix G)

i. On or about 1 Aug 02, you violated Article 92, UCMJ, by disobeying a direct order by not completing your homework assignment, for which you received a Letter of Reprimand, dated 6 Aug 02. (Atch 1, Appendix I w/atchs)

j. On or about 1 Aug 02, you were late for a mandatory formation, for which you received a Letter of Counseling, dated 5 Aug 02. (Atch 1, Appendix J w/atch)

k. On or about 25 Jul 02, you failed your dormitory room inspection, as noted on AETC Form 341, dated 25 Jul 02. (Atch 1, Appendix K)

3. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising SPCM jurisdiction or higher will decide whether you will be discharged or retained in the Air Force, and, if you are discharged, how your service will be characterized. If you are discharged, you will be ineligible for reenlistment in the Air Force. Any special pay, bonuses, or education assistance funds may be subject to recoupment.

4. You have the right to consult legal counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult  $\underline{\mathcal{N}} \underline{\mathcal{A}}$  at Bldg 0701, Room 133, on  $\underline{\mathcal{N}} \underline{\mathcal{A}}$  at  $\underline{\mathcal{N}} \underline{\mathcal{A}}$  hours. 6. If you fail to consult counsel or to submit statements in your own behalf, your failure will constitute a waiver of your right to do so.
