# AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2005-00311

**GENERAL:** The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

**FINDINGS**: Upgrade of discharge is denied.

The Board finds that neither the evidence of record nor that provided by the applicant substantiates an inequity or impropriety that would justify a change of discharge.

**ISSUE**: The Board finds that the applicant submitted no issues contesting the equity or propriety of the discharge and after thorough review of the record, the board was not able to identify any issues. The records indicated that the applicant received an Article 15, four Letters of Reprimand, one Letter of Counseling and three Records of Individual Counseling for misconduct. The misconduct included Article 128, Assault; failure to go, dereliction of duty and late for duty. The Board opined that through these administrative actions the applicant had ample opportunities to change his behavior. The Board concluded the misconduct was a significant departure from conduct expected from all military members. The characterization of the discharge received by the applicant was found to be appropriate.

The applicant cited his desire to receive the G.I. Bill benefits as justification for upgrade. The DRB noted that when the applicant applied for these benefits, he signed a statement (DD Form 2366, on August 8, 2004) that he understood he must receive an Honorable discharge to receive future educational entitlements. The Board was sympathetic to the impact the loss of these benefits was having on the applicant, but this is not a matter of inequity or impropriety which would warrant an upgrade.

**CONCLUSIONS:** The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

SUBJECT: Notification Memorandum

1. I am recommending your discharge from the United States Air Force for misconduct, specifically minor disciplinary infractions. The authority for this action is AFPD 36-32 and AFI 36-3208, paragraph 5.49. If my recommendation is approved, your service will be characterized as honorable or general. I am recommending that your service be characterized as a general discharge.

# 2. My reasons for this action are:

- a. You did, at or near Eglin Air Force Base, Florida, on or about 18 September 2004, unlawfully pull on the arm and shove into a passenger side vehicle door Mrs. your wife, with your hands. For this offense you received nonjudicial punishment, dated 13 October 2004
- b. On 1 July 2004, you failed to go at the time prescribed to wit: Building 103, Eglin AFB, Florida, at designated show time of 2200. For this offense you received a letter of reprimand, dated 2 July 2004.
- c. On 24 February 2004, you failed to go at the time prescribed to wit: Building 103, Eglin AFB Florida, at the designated show time of 0630. You reported to work after 0700. For this offense you received a letter of reprimand, dated 24 February 2004.
- d. On 28 October 2003, you failed to report to your appointed place of duty. For this offense you received a letter of reprimand, dated 30 October 2003.
- e. On 22 July 2003, you signed out various avionics CTK EGBS-03 for use in your maintenance activities. The TAS computer shows that you signed out this equipment, however, you failed to sign the 46 TW form 309 that is in the CTK binder as required in TWI 21-128, para 4.3. For this offense you received a letter of reprimand, dated 23 July 2003.
- f. On 1 April 2003, you worked on the flight line using toolbox EGBS03. The toolbox was turned in at the end of the shift with no incident reported. In the morning day shift noticed that you failed to properly fill out AF 309, and you did not report any tools missing and in fact the ½" universal adaptor was missing. For this offense you received a letter of counseling, dated 2 April 2003.

- g. On 6 January 2003 and were to report to work at 0600. You discust arrive until 0635. Your job was to arrive at 0600 and do shop inventory prior to dayshift arriving. For this offense you received a record of individual counseling, dated 6 January 2003.
- h. On the night of 29 May 2002, you were observed skipping information in the T.O. while performing an IFF operational checkout. On numerous occasions you were told to read every step, note, caution and warning. For this offense you received a record of individual counseling, dated 30 May 2002.
- i. As class leader, you are charged with the additional responsibilities and duties to assist your instructor with student supervision. You have failed in maintaining a positive attitude and enhancing the classroom environment. You have also failed in helping enforce proper discipline, conduct and behavior of your class and yourself. You are hereby relieved of your duties as class leader. For this offense you received a record of individual counseling, dated 13 May 2002.
- 3. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising SPCM jurisdiction or higher authority will decide whether you will be discharged or retained in the United States Air Force and, if you are discharged, how your service will be characterized. If you are discharged, you will be ineligible for reenlistment in the Air Force and any special pay, bonus, or education assistance funds may be subject to recoupment.
- 4. You have the right to consult counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult Captain:

  at 904 N. 2nd Street, on 21 October 2003, at 1400 hours. You may consult civilian counsel at your own expense.
- 5. You have the right to submit statements in your own behalf. Any statements you want the separation authority to consider must reach me within 3 duty days unless you request and receive an extension for good cause shown. I will send them to the separation authority.
- 6. If you fail to consult counsel or to submit statements in your own behalf, your failure will constitute a waiver of your right to do so.
- 7. You have been scheduled for an appointment with the 96th Mission Support Squadron, separations section, on 25 October 2004 at 1300 hours.
- 8. After your briefing, you are to report to the 96th Traffic Management Office with your completed AFDTC Form 4134 or LGTT Office Form B133 along with an authorized letter from separations to schedule your TMO pickup.
- 9. You are required to receive a briefing from the Family Support Center prior to your separation. You have been scheduled to receive your Transition Assistance Management Program (TAMP) briefing on 26 October 2004 at 0800 hours.
- 10. You have been scheduled for a medical examination. You must report to 96 MDG Force Health Management, 307 Boatner Rd. on 22 October 2004, at 0715 hours for the examination.
