AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2005-00393

GENERAL: The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is denied.

The Board finds that neither the evidence of record nor that provided by the applicant substantiates an inequity or impropriety that would justify a change of discharge.

ISSUE:

Issue 1. Applicant contends discharge was inequitable because it was too harsh. The records indicated the applicant received two Article 15's, six Letters of Reprimand and one Letter of Counseling for misconduct. The Article 15's were for failure to report at the time prescribed as his appointed place of duty and derelict in the performance of duties in that he negligently failed to properly prepare the primary ammo can with the appropriate items or assure that the items were available. As a result, applicant was punished with a reduction in grade and forfeiture of pay. The records indicated applicant received six Letters of Reprimand for dereliction of duty, unauthorized use of Government Travel Card, late for duty, improper wear of uniform, and speeding. Applicant also received a Letter of Counseling for addressing NCOs inappropriately and speeding. The DRB opined that through these administrative actions, the applicant had ample opportunities to change his negative behavior. The Board concluded the misconduct was a significant departure from conduct expected of all military members. The characterization of the discharge received by the applicant was found to be appropriate.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings, the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.
