# AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2005-00443

GENERAL: The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is denied.

The Board finds that neither the evidence of record nor that provided by the applicant substantiates an inequity or impropriety that would justify a change of discharge.

**ISSUE:** Applicant received a General discharge for Misconduct – Drug Abuse

Applicant submitted no issues. The records indicated the applicant received an Article 15 for wrongfully using marijuana. Given the Air Force zero tolerance for wrongful use of drugs, the Board concluded the misconduct was a significant departure from conduct expected of all military members and the characterization of the discharge received by the applicant was found to be appropriate.

**CONCLUSIONS:** The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

2. My reason for this action is between on or about 1 Dec 04 and on or about 28 Dec 04, you wrongfully used Marijuana, as documented by an AF 3070, Record of Nonjudicial Punishment Proceedings, dated 12 Apr 05 and a Report of Investigation, dated 4 Mar 05.

4. Military counsel may be obtained to assist you. Contact TSgt (extension 4-2362) at the Area Defense Counsel's office, to schedule an appointment with the Area Defense Counsel (ADC). You may have a military counsel other than the ADC, if the lawyer you request is in the active military service and is reasonably available as determined according to AFI 51-201. In addition to military counsel, you have the right to employ civilian counsel. The Air Force does not pay expenses incident to the employment of civilian counsel. Civilian counsel, if employed, must be readily available.

5. You have the right to submit a statement on your behalf. Any statements you want the Separation Authority to consider must reach me by  $\frac{3May}{0.5}$  at  $\frac{1600}{0.00}$  unless you request and receive an extension for good cause shown. Any submitted statements will be forwarded to the Separation Authority.


6. If you fail to consult counsel or to submit statements on your behalf within three duty days, your failure will constitute a waiver of your right to do so.

7. You have been scheduled for a medical examination. You must report to the Pope AFB Flight Medicine Clinic on  $\underline{6 \text{ May}}$  at  $\underline{1300}$  hours for the examination.
