# AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2006-00028

**GENERAL:** The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is denied.

The Board finds the applicant submitted no issues contesting the equity or propriety of the discharge, and after a thorough review of the record, the Board was unable to identify any that would justify a change of discharge.

**ISSUE:** The applicant stated that he wished to reenlist in the Air National Guard as his justification for upgrade. The records indicated the applicant received three Memorandums for Record for unsatisfactory performance. The unsatisfactory performance included 12 unexcused absences from his Air National Guard unit in a 12-month period. The DRB opined that through these administrative actions, the applicant had ample opportunities to change his negative behavior. The characterization of the discharge received by the applicant was found to be appropriate.

**CONCLUSIONS:** The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

SUBJECT: Letter of Notification (LON) for Recommendation of Involuntary Discharge

1. I am recommending your discharge from the Air National Guard. The authority for this action is AFI 36-3209, chap 3, para 3.13.2.

2. The reason for this action is Unsatisfactory Participation. Unsatisfactory participation is having nine or more unexcused absences from Unit Training Assemblies (UTA) within a 12 month period. You have a total of 12 unexcused absences in the past 12 month period. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached.

3. I am recommending that you receive a General discharge (under honorable conditions). The Adjutant General of the Idaho Air National Guard (IDANG) is the discharge authority for this action.

4. You are entitled to:

a. Present your case to an administrative discharge board.

<u>b. Consult legal counsel.</u> Military legal counsel has been obtained to assist you. You may contact Maj the IDANG Staff Judge Advocate, at 422-5474, to make arrangements for military counsel. You may consult civilian counsel at your own expense.

c. Submit any statements or documents to be considered in disposition of the case. Requests for a waiver of a board hearing does not affect the right to submit statements or documents at anytime.

d. Apply for transfer to the Retired Reserve if eligible for such transfer.

5. You may waive the above rights, as well as the right to an administrative discharge board hearing, after having the opportunity to consult with counsel.

Return Attachment 1 within 24 hours acknowledging receipt of LON.

7. Return Attachment 2 within 15 days after receipt of LON. Return Attachment 3 if requesting a board hearing.

8. A copy of AFI 36-3209 is available for your use in building NG-400. Attachment 14 to AFI 36-3209 is the Privacy Act Advisory covering any personal information you furnish.

9. Failure to acknowledge receipt or respond regarding selection of rights within 15 days after receipt of LON constitutes a waiver of all rights, resulting in the case being processed without an administrative board hearing on the information available.
