## AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2006-00098

**GENERAL:** The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

**FINDINGS**: Upgrade of discharge is denied.

The Board finds that neither the evidence of record nor that provided by the applicant substantiates an inequity or impropriety that would justify a change of discharge.

## **ISSUE**:

Issue 1. Although not explicitly stated, the applicant contends his discharge was inequitable because it was too harsh. The records indicated the applicant received two Article 15's, three Letters of Reprimand, two Letters of Counseling, a Record of Individual Counseling and two Memorandums for Record for misconduct. The applicant was administratively disciplined for losing his military identification card on four separate occasions, financial irresponsibility, and dereliction of duty. He had further misconduct and received his first Article 15 for failing to keep his dorm room in good order. He was reduced in grade to Airman First Class and received 30 days of extra duty which was suspended. His second Article 15 was for failing to obey an order from a Security Forces member to return to his dormitory room, argued with provoking speeches and gestures. He received a reduction in grade to Airman and fourteen days of extra duty. The DRB opined that through these administrative actions, the applicant had ample opportunities to change his negative behavior. The Board concluded the misconduct was a significant departure from conduct expected of all military members. The characterization of the discharge received by the applicant was found to be appropriate.

Issue 2. Applicant states that his discharge did not take into account the good things he did while in the service. The DRB took note of the applicant's duty performance as documented by his performance reports, letters of recommendation and other accomplishments. They found the seriousness of the willful misconduct offset any positive aspects of the applicant's duty performance. The Board concluded the discharge was appropriate for the reasons which were the basis for this case.

**CONCLUSIONS:** The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings, the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

1. I am recommending your discharge from the United States Air Force for minor disciplinary infractions. The authority for this action is AFPD 36-32 and AFI 36-3208, paragraph 5.49. If my recommendation is approved, your service will be characterized as honorable or general. I am recommending that your service be characterized as general.
2. My reasons for this action are:
(a) On or about 23 July 1994, you lost your military ID Card (DD Form 2AF). For this, you received counseling as per letter dated 29 July 94.
(b) On or about 2 Sep 94, you lost your military ID Card (DD Form 2AF). For this you received counseling as per letter dated 8 Sep 94.
(c) On or about 13 Sep 94, you lost your military ID Card (DD Form 2AF). For this you were given a letter of counseling as per Record of Individual Counseling form (AF Form 170) dated 13 Sep 94.
(d) On or about 21 Jul 94, you had your tote bag stolen containing your line badge. For this you you were verbally counseled by SSgt on the importance of properly securing your line badge at all times as per letter dated 26 Sep 94.
(e) On or about 8 May 1995, you lost your military ID Card (DD Form 2AF). For this you received a Letter of Reprimand as per letter dated 16 May 1995. You also had an Unfavorable Information File (UIF) established and were placed on a Control Roster.
(f) On or about 13 Mar 95 and between on or about 15 May 95, you knew of your duties at


- (g) On or about 3 Oct 95; the First Sergeant received a "past due 2 notice on your AAFES".

- (h) On or about 7 Nov 95, you lost the keys to the 621 AMOS EZ-Go and failed to notify anyone of the lost. This was a major security violation of government equipment. For this you received a security counseling, dated 14 Nov 95.
- (i) On or about 8 Nov 95, you did not perform your analysis duties to the standards established for all maintenance data and briefings. For this you received a Letter of Counseling, dated 14 Nov 95.
- (j) On or about 18 Nov 95, you lost your military ID Card, DD Form 2AF. For this you received a Letter of Reprimand, dated 1 Dec 95.

- (k) On or about 18 Nov 95, you were placed under apprehension for Failure to Obey an Order or Regulation, Interfering with the Duties of a Security Policeman, and Provoking Speeches and Gestures. For this you received an Article 15, under the Uniform Code of Military Justice, consisting of a reduction in grade to (E-2) (Airman) and 14 day extra duty. This action was taken on 7 Dec 95.
- (1) On or about 24 Jan 96, the First Sergeant received a "past due" notice from your AAFES Deferred Payment Plan, dated 21 Jan 96. For this, you were given a Letter of Reprimand, dated 1 Feb 96

Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising SPCM jurisdiction or a higher authority will decide whether you will be discharged or retained in the Air Force, and if you are discharged, how your service will be characterized. If you are discharged, you will be ineligible for reenlistment in the Air Force.

- 3. You have the right to consult counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult Capt \_\_\_\_\_at building 2906 on 13 February 1996 at 0900. You may consult civilian counsel at your own expense.
- 4. You have the right to submit statements in your behalf. Any statements you want the separation authority to consider must reach me by 16 February 1996 unless you request and receive an extension for good cause shown. I will send them to the separation authority.
- 5. If you fail to consult counsel or to submit matters in your own behalf, your failure will constitute a waiver of your right to do so.
- 6. You have been scheduled for a medical examination. You must reported to Walson Air Force Hospital on Fort Dix at 0745 on 5 February 1996 for the examination.
- 7. Any personal information you furnish in your rebuttal is covered by the Privacy Act of 1974. A copy of AFI 36-3208, is available for your use in the squadron orderly room.
