You are ineligible for reenlistment in the Air Force if your discharge is approved.

Any matters and statements you submit will be forwarded to the separation authority.
- 6. If you fail to consult counsel or to submit statements in your own behalf, your failure will constitute a waiver of your right to do so.
- 7. You have been scheduled for a mandatory medical appointment. You are to report to the 22d Medical Squadron, Physical Exams Section, on 5 (a) 05 at 0930 hours.
- 8. If you live in base housing, you must contact the housing office immediately upon receipt of this notification.
