AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2006-00249

GENERAL: The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is denied.

The Board finds that neither the evidence of record nor that provided by the applicant substantiates an inequity or impropriety that would justify a change of discharge.

ISSUES:

Issue 1. Applicant contends discharge was inequitable because it was too harsh. The records indicated the applicant received two Article 15s, one Letter of Reprimand, one Letter of Counseling, and one Record of Individual Counseling for misconduct. The misconduct included insubordinate conduct towards a noncommissioned officer, dereliction of duty, failure to go, unlawfully entering the dorm room of two female airmen, fleeing from armed forces policemen, failing to obey by wrongfully exiting an armed forces police vehicle, resisting apprehension by an armed forces policeman, making a false official statement and failing to install a forward track safety pin in preparing ammunition for removal. The DRB opined that through these administrative actions, the applicant had ample opportunities to change his negative behavior. The Board concluded the misconduct was a significant departure from conduct expected of all military members. The characterization of the discharge received by the applicant was found to be appropriate.

Issue 2. Applicant states that his discharge did not take into account the good things he did while in the service. The DRB took note of the applicant's duty performance as documented by his performance reports, letters of recommendation and other accomplishments. They found the seriousness of the willful misconduct offset any positive aspects of the applicant's duty performance. The Board concluded the discharge was appropriate for the reasons which were the basis for this case.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

- 1. I am recommending your discharge from the United States Air Force for minor disciplinary infractions. The authority for this action is AFPD 36-32 and AFI 36-3208, Chapter 5, Section H, Paragraph 5.49. If your discharge is approved, your service will be characterized as honorable or under honorable conditions (general). I am recommending that your service be characterized as under honorable conditions (general).
- 2. My reasons for this action:
- a. On or about 13 Feb 05, you unlawfully entered the dorm room of Senior Airman:

 On or about 4 Dec 04, you unlawfully entered the dorm room of Senior Airman

 For this misconduct, you received an Article 15, dated 5 May 05.
- b. On or about 1 Oct 05, you failed to report to work for weekend duty. For this misconduct, you received a Letter of Reprimand, dated 3 Oct 05.
- c. On or about 19 Oct 05, you failed to stop and perform a FOD check and remove your hat as required. For this misconduct, you received a Record of Individual Counseling, dated 22 Oct 05.
- d. On or about 30 Nov 05, you were disrespectful in nature to an NCO. For this misconduct, you received a Letter of Counseling, dated 30 Nov 05.
- e. On or about 22 Sep 05, you failed to obey a lawful order given by a Security Forces member to "halt" and continued to flee. You also resisted arrest and failed to remain in the vehicle when told by Security Forces personnel. Lastly, you falsely informed Security Forces that your name was SrA:

 when questioned about who you were. On 26 Oct 05, you failed to install the forward track safety pin in preparing a munition for removal in accordance with Air Force Technical Order 1F-16C-33-1-2CL-14. For this misconduct, you received an Article 15, dated 14 Dec 05.
- 3. Copies of the documents to support this recommendation are attached and will be forwarded to the separation authority. The separation authority will make the findings and recommendations required under 10 U.S.C. 2005(g) regarding recoupment of education assistance funds, if applicable. The commander exercising special court-martial jurisdiction or a higher authority will decide whether you will be discharged or retained in the Air Force and, if



ineligible for reenlistment in the Air Force and any special pay, bonus, or education assistance funds may be subject to recoupment.

- 4. You have the right to consult counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult Captain:

 ; Area Defense Counsel, 895-9530, 321 Cullen Street, at <u>0830</u> hours on <u>/8 Jan</u> 2006. You may consult civilian counsel at your own expense.
- 5. You have the right to submit statements in your own behalf. Any statements you want the separation authority to consider must reach me by 6.50 hours on 2006 unless you request and receive an extension for good cause shown. I will send them to the separation authority.
- 6. If you fail to consult counsel or to submit statements in your own behalf, your failure will constitute a waiver of your right to do so.
- 7. You have been scheduled for a medical examination. You must report to the 20th Medical Group, Primary Care Clinic at /000 hours on /8 Jan 2006 and an additional examination will be scheduled if necessary.
- 8. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. A copy of AFI 36-3208 is available for your use in the unit orderly room.
