AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2006-00317

GENERAL: The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is denied.

The Board finds the applicant submitted no issues contesting the equity or propriety of the discharge, and after a thorough review of the record, the Board was unable to identify any that would justify a change of discharge.

ISSUE:

The applicant submitted no issues and requested that the review be completed based on the available service record. The Board reviewed the entire record and found no evidence of impropriety or inequity in this case on which to base an upgrade of discharge. The records indicated applicant had received two Article 15's and a Letter of Reprimand for misconduct. His first Article 15 was for failure to obey a no-contact order. He was reduced in grade to Airman Basic with reduction below Airman suspended, restricted to Luke AFB for 45 days, and 30 days of extra duty. His second Article 15 was for signing an official statement with intent to deceive and writing checks with insufficient funds. He was punished with a reduction in grade to Airman Basic, 45 days extra duty and a reprimand. He was also administratively disciplined with a Letter of Reprimand for dereliction of duty. The DRB opined that through these administrative actions, the applicant had ample opportunities to change his negative behavior. The Board concluded the misconduct was a significant departure from conduct expected of all military members. The characterization of the discharge received by the applicant was found to be appropriate.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings, the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

1. I am recommending your discharge from the United States Air Force for Misconduct: Minor Disciplinary Infractions. The authority for this action is AFPD 36-32 and AFI 36-3208, paragraph 5.49. If my recommendation is approved, your service will be characterized as honorable or under honorable conditions (general). I am recommending that your service be characterized as under honorable conditions (general).

2. My reason for this action is:

icell phone, contacting her daughter over the phone and meeting with Mrs. in the Wal-Mart parking lot. For this misconduct, you received an Article 15 dated 6 Nov 03. Your punishment included a suspended reduction in rank to the grade of E-2, restriction to the limits of Luke Air Force Base, Arizona for 45 days and 30 days extra duty. This action established an Unfavorable Information File (UIF). (Tab 7A)



If you are discharged, you will be ineligible for reenlistment in the Air Force and any special pay, bonus, or education assistance funds may be subject to recoupment. The separation authority will make the findings and recommendations required under 10 U.S.C. Section 2005.

3. You have the right to consult counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult Captain ________at 7383 N. Litchfield Rd., Bldg. 1150, ext 6701, on <u>12 Aug</u> 05 _____, at <u>TEO</u> hours. You may consult civilian counsel at your own expense.

4. You have the right to submit statements in your own behalf. Any statements you want the separation authority to consider must reach me by $(\mathcal{L}A_{mg}, \partial \mathcal{T})$, which is three duty days from the date of this letter, unless you request and receive an extension for good cause shown. I will send them to the separation authority.

5. If you fail to consult counsel or to submit statements in your own behalf, your failure will constitute a waiver of your right to do so.

6. You must report to 56th Medical Group, for a medical examination. You must retrieve your medical records from 56th Medical Group Hospital Outpatient Records and immediately report to Physical Exams, Building 810, with your medical records and your copy of this discharge file for the medical examination.
