## AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

### FD-2006-00338

**GENERAL:** The applicant appeals for upgrade of discharge to honorable, to change the reason for discharge, and to change the reenlistment code.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge, change of reason and authority for the discharge, and change of reenlistment code are denied.

The Board finds that neither the evidence of record nor that provided by the applicant substantiates an inequity or impropriety that would justify a change of discharge.

## ISSUE:

Applicant contends discharge was inequitable because it was too harsh. The record indicates that the applicant received six Letters of Reprimand and a Letter of Counseling for misconduct. The misconduct included four failures to go, three late for work, three instances of dereliction of duty, illegal parking and a failure to obey a lawful order. The applicant did not submit any additional documents or statements on his behalf. After review of the record, the Board opined that through these administrative actions, the applicant had ample opportunities to change his negative behavior. The Board found the seriousness of the willful misconduct offset any positive aspects of the applicant's duty performance and concluded that the characterization, reason for discharge and reenlistment code were appropriate for the reasons which were the basis for this case.

**CONCLUSIONS:** The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings, the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge, reason for discharge and reenlistment code should not be changed.

SUBJECT: Notification Letter

1. I am recommending your discharge from the United States Air Force for Minor Disciplinary Infractions. The authority for this action is AFPD 36-32 and AFI 36-3208, paragraph 5.49. If my recommendation is approved, your service will be characterized as honorable or general (under honorable conditions). I am recommending that your service be characterized as general (under honorable conditions).

2. My reasons for this action are:

a. On or about 15 Dec 02, you failed to complete Volume 1 of your CDCs as it was your duty to do so. After being given a lawful order on 24 Dec 02 to have your Volume 1 completed by 28 Dec 02, you failed to meet that deadline as well. For disobeying a lawful order, you received a Letter of Reprimand (LOR) dated 29 Dec 02 (Atch 1).

b. On or about 3 Jan 03, you still had not scheduled an appointment to attain a USAREUR driver's license as you had been instructed to do back in Nov 02. For disobeying a lawful order, you received an LOR dated 4 Jan 03 (Atch 2).

c. On or about 9 Jan 03, you failed to go at the time prescribed to your appointed place of duty. For this infraction, you received an LOR dated 9 Jan 03 (Atch 3).

d. On or about 9 Mar 03, you failed to go at the time prescribed to your appointed place of duty. For this infraction, you received an LOR dated 18 Mar 03 (Atch 4).

e. On or about 7 Apr 03, you were issued a DD Form 1408, Armed Forces Traffic Ticket, for parking in a fire lane at Dormitory 335. For this infraction, you received a Letter of Counseling dated 16 Apr 03 (Atch 5).

f. On or about 5 Jul 03, you were found to be derelict in your duties as a security forces member. After having been instructed by your flight chief to conduct a walking patrol in Speicher for 2 hours, you notified the control center that you were conducting this patrol. Investigation revealed, however, that you were actually at another security forces member's residence. For this infraction, you received an LOR dated 18 Jul 03 (Atch 6).

g. On or about 15 and 17 Jul 03, you failed to show for mandated study time for your end of course exam; on or about 16 Jul 03, you missed your SMART medical appointment; on or

about 19 and 20 Jul, you reported late for duty. For these infractions, you received an LOR dated 30 Jul 03 (Atch 7).

3. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising SPCM jurisdiction or a higher authority will decide whether you will be discharged or retained in the Air Force. If you are discharged, you will be ineligible for re-enlistment in the Air Force and any special pay, bonus, or education assistance funds may be subject to recoupment.

4. You have the right to consult counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult Capt \_\_\_\_\_\_\_\_\_ at Spangdahlem AB, Germany, DSN 452-6607, on  $\frac{20}{443}$  at 0930 hours. You may consult civilian counsel at your own expense.

5. You have the right to submit statements on your own behalf. Any statements you want the separation authority to consider must reach me <u>within three duty days</u>, unless you request and receive an extension in writing for good cause shown. I will send them to the separation authority.

6. If you fail to consult counsel or to submit statements on your own behalf, your failure will constitute a waiver of your right to do so.

7. You have been scheduled for a medical examination. You must report to your **PRIMARY** <u>CARE MANAGER</u> on <u>19</u> App at <u>1005</u> hours. You must report 15 minutes prior to your appointment.

8. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. A copy of AFI 36-3208 is available for your use in the Commander's Support Staff office.

9. Execute the attached acknowledgment and return it to me immediately.
