AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2006-00357

GENERAL: The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is denied.

The Board finds the applicant submitted no issues contesting the equity or propriety of the discharge, and after a thorough review of the record, the Board was unable to identify any that would justify a change of discharge.

ISSUE: Applicant submitted no issues on his own behalf. The records indicated the applicant received two Article 15s, one Letter of Reprimand, and two Records of Individual Counseling for misconduct. The misconduct included failure to obey a direct order, failure to respond to a military recall, and failure to go. The Board acknowledged that the member received a clinical evaluation of his sleep functioning in search of a possible organic cause of his frequent tardiness in reporting to duty. However, the member's sleep study demonstrated "snoring with mild obstructive sleep disordered breathing not currently diagnostic of significant obstructive sleep apnea/hypopnea syndrome" which the board believed did not mitigate either his chronic recurrent tardiness or other misconduct. The DRB opined that through the administrative actions cited above, the applicant had ample opportunities to change his negative behavior. The Board concluded the misconduct was a significant departure from conduct expected of all military members. The characterization of the discharge received by the applicant was found to be appropriate.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.
