AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

GENERAL: The applicant appeals to change the reason and authority for discharge and to change the reenlistment code.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Request for change of reason and authority for discharge and change of reenlistment code are denied.

The Board finds the applicant submitted no issues contesting the equity or propriety of the discharge, and after a thorough review of the record, the Board was unable to identify any that would justify a change of discharge.

ISSUE:

Applicant requests that the reason (unsatisfactory performance) for his discharge be changed to "Failure to progress in OJT" or "For the Convenience of the Government." Applicant concludes that he should not be labeled with "Unsatisfactory Performance" and has expressed a desire to reenlist into the armed forces. The DRB opined that the reason for discharge was Unsatisfactory Performance which is in accordance with AFI 36-3208, paragraph 5.26.3, Failure to progress in on-the-job training (OJT). This reason would include individuals who fail to upgrade in a timely manner or as is in his case failed to pass the Career Development Course (CDC) exam on two separate occasions. An involuntary discharge for the Convenience of the Government would only be appropriate when discharge would serve the best interests of the Air Force and the discharge for cause is not warranted. The Board concluded the reason for the discharge received by the applicant was found to be appropriate.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings, the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

SUBJECT: Notification Memorandum

1. I am recommending your discharge from the United States Air Force for Unsatisfactory Performance, specifically Failure to Progress in on the job training (OJT). The authority for this action is AFPD 36-32, *Military Retirements and Separations*, and AFI 36-3208, *Administrative Separation of Airman*, Chapter 5, *Reasons For Involuntary Separation*, Section E, *Unsatisfactory Performance*, Paragraph 5.26.3, *Failure to Progress in on-the-job-training (OJT)*. If my recommendation is approved, your service will be characterized as honorable or general. I am recommending that your service be characterized as honorable.

2. My reasons for this action are:

a. On 20 Nov 00, you failed the end of course examination for a required course, number 3S051A. Your score was 54; you needed a passing score of 65. As a result, you were entered into supervised study in an effort to prepare you for your retest (see Atch 1).

b. On 24 Jan 01, you were briefed on the consequences if you were to fail your end of course examination a second time. In an effort to overcome your unsatisfactory performance, it became mandatory for you to study two hours a day during the week and MSgt your previous supervisor also continued with your training (see Atch 2).

c. On 20 Feb 01, you failed the end of course examination for a required course, number 3S051A. Your score was 57; you needed a passing score of 65. This was your second test failure for the same course. This second failure has rendered you unfit to continue in your AFSC (see Atch 3).

3. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising SPCM jurisdiction or a higher authority will decide whether you will be discharged or retained in the Air Force and, if you are discharged, how your discharge will be characterized. If you are discharged, you will be ineligible for reenlistment in the Air Force and any special pay, bonus, or education assistance funds may be subject to recoupment.

4. You have the right to consult counsel. Military legal counsel has been obtained to assist you. Please consult the Area Defense Counsel (Capt or Capt at Keesler AFB at DSN 597-2429 or (228) 377-2429. You may consult civilian counsel at your own expense.

5. You have the right to submit statements in your own behalf. Any statements you want the separation authority to consider must reach me by COB <u>24 MAY 200/</u> (three workdays from your receipt of this notification memorandum) unless you request and receive an extension for good cause shown. I will send them to the separation authority.

6. If you fail to consult counsel or to submit statements in your own behalf, your failure will constitute a waiver of your right to do so.

7. You have been scheduled for a medical examination. You must report to the Columbus AFB Clinic, Physical Exam Section at <u>0730</u> on <u>22 May 01</u> for the examination.

8. Any personal information you furnish in rebuttal is covered by the Privacy Act. A copy of AFI 36-3208 is available for your use in your unit orderly room.
