AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2006-00455

GENERAL: The applicant appeals for upgrade of discharge to honorable, change reason for discharge, and change of reenlistment code.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is granted.

Change of reason and change of reculistment code are denied.

The Board finds that neither the evidence of record nor that provided by applicant substantiates an impropriety that would justify a change of discharge. However, based upon the record and evidence provided by applicant, the Board finds the applicant's characterization for discharge inequitable.

ISSUE:

Applicant contends her discharge was inequitable because it was too harsh. Applicant believes her command could have waived or given her another opportunity considering the sensitive situation she was in (an abusive relationship and an unborn child). The applicant received a General discharge for Unsatisfactory Performance. The records indicated that the applicant failed her end of course exam twice. After a thorough review of the record, the Board found the characterization of the discharge harsh based on the lack of evidence that her command had provided the required remedial training needed for the applicant's success in taking her end of course exam. The Board grants relief for upgrade of the characterization of the discharge to Honorable. However, the Board did not find any sufficient mitigation to substantiate changing the reason for discharge or the reenlistment code.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings, the Board believes that the relief for the characterization of the discharge should be granted. The applicant's characterization should be changed to Honorable under the provisions of Title 10, USC 1553.

- I am recommending your discharge from the Ohio Air National Guard and as a Reserve in the United States Air Force for Unsatisfactory Performance, according to AFI 36-3209, under the provisions of para 3.18.6. Copies of the documents to be forwarded to the separation authority to support this recommendation are in attachment
 Verification of attachment 1 can be accomplished by reviewing your training records in the Education and Training office.
- 2. My reasons for this action are your failure to attain required job skill proficiency.
- 3. This action could result in your separation with a General Discharge. I am recommending you receive a general discharge. The Adjutant General of Ohio as discharge authority will make the final decision in this matter. If you are discharged, you will be ineligible for reenlistment in the Ohio Air National Guard and will probably be denied enlistment in any component of the Armed Forces. If you received advanced education assistance moneys or special pay or bonuses you may be required to repay the US for these moneys under the authority 10 U.S.C., Section 2005)
- 4. You have the right to:
 - a. Consult legal counsel.
 - b. Submit statements in your own behalf.
 - c. Waive your above rights.
- 5. Military legal counsel, Lt Col, 178 FW/JAG, Phone (614) 462-5420 or DSN 346-2206, is available to assist you. Instead of the appointed counsel, you may have another, if the lawyer you request is in the active military service and is reasonable available as determined according to AFI 51-201. In addition to military counsel, you have the right to employ civilian counsel. The Air Force does not pay expenses incident to the employment of civilian counsel. Civilian counsel, if employed, must be readily available.
- 6. Confer with your counsel and reply in writing, within 30 days from the date of this letter, specifying the rights you choose to exercise (see attachment 3). The statement must be signed The appropriate authority will consider granting an extension of the time to reply if additional time is needed by respondent or counsel. Respondent or counsel must submit a written request for such delay, stating the reasons and how much time is needed. The decision whether to grant the additional time is discretionary with the appropriate authority.
- 7. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. A copy of AFI 36-3209 is available for your use in the 123 ACS Orderly Room.
- 8. Execute the attached acknowledgment and return it to me within 24 hours after receipt of this letter of notification and attachments. (Attachment 2)

9. Within 30 days after receipt of this letter, return the enclosed Statement of Selection of Options to 123 ACS/CC, Blue Ash ANG Station, 10649 McKinley Road, Cincinnati, Ohio 45242-3797. Failure to acknowledge receipt within 24 hours to respond concerning selection of options within 30 days after receipt of this letter, or to request an extension of this time limit constitutes a waiver of your rights and options as described in the paragraphs 4 and 6 above.
