- 1. Pursuant to the provisions of reference (a), Subject hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show advanced when first eligible.
- The Board, consisting of Messrs. Exnicios, Goldsmith, and Pfeiffer, reviewed Petitioner's allegations of error and injustice on 13 April 1999 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. - Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

CONCLUSION
