- 1. Pursuant to the provisions of reference (a), Subject hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show advanced when first eligible.
- 2. The Board, consisting of Messrs. Kastner, Mazza, and Ms. McCormick, reviewed Petitioner's allegations of error and injustice on 25 May 1999 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record.
