

REVIEW OF NAVAL RECORD

- 1. Pursuant to the provisions of reference (a), Subject hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show Petitioner was entitled to Variable Housing Allowance (VHA) at the single rate.

- b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

- a. Petitioner was authorized VHA at the single rate for assigned duty station for the period 5 November 1995 through 8 February 1999. (Petitioner was released from active duty on 8 February 1999 and his mailing address is 504 South Alandele Ave., Los Angeles CA 90036.)
 - b. That a copy of this Report of Proceedings be filed in Petitioner's naval record.
- 4.
