Dear The Land

This is in reference to your application for correction of your naval record pursuant to the provisions of Title 10 of the United States Code, section 1552.

A three-member panel of the Board for Correction of Naval Records, sitting in executive session, considered your application on 11 December 2001. Your allegations of error and injustice were reviewed in accordance with administrative regulations and procedures applicable to the proceedings of this Board. Documentary material considered by the Board consisted of your application, together with all material submitted in support thereof, your naval record and applicable statutes, regulations and policies. In addition, the Board considered the statement of service furnished by Headquarters Marine Corps, a copy of which is enclosed.

After careful and conscientious consideration of the entire record, the Board found that the evidence submitted was insufficient to establish the existence of probable material error or injustice.

As indicated in the enclosures, you have been credited with 16 years and 12 days of qualifying service for reserve retirement based on your service in the Marine Corps. In order to be eligible for reserve retirement at age 60, you need 20 years of qualifying service. A qualifying year is one in which you earned at least 50 retirement points. The statement of service shows that in the anniversary year ending 30 June 1956, you have only been credited with 38 points. Accordingly, it is not qualifying for reserve retirement.

You have submitted documentation showing that you enlisted in the Air Force Reserve on 10 December 1962 for three years and served until you were honorably discharged on 9 December 1965. With your application, you have submitted a copy of a letter from Headquarters Air Reserve Personnel Center, dated 24 August 1976, stating that you had completed 18 years, 7 months & 5 days of qualifying service. You were advised that you had to have 20 qualifying years in order to be eligible for retired pay. However, you apparently took no action to establish your eligibility for reserve retired pay at that time.

The Board is aware that your request for reserve retirement was

denied by the Board for Correction of Air Forces Records (AFBCMR) on 26 June 2001. The denial was essentially based on the fact that you has only completed 18 years, 7 months and 5 days of qualifying service, and had not responded to the 24 August 1976 letter.

As indicated the anniversary ending 30 June 1956 is the only year in which the Board could correct your record to show a qualifying year. However, even if the Board were to correct the record to show that this year was qualifying for reserve retirement, you would still only have 19 years, 7 months and 5 days of qualifying service, and would still not be eligible for reserve retirement. Since you did not take action to qualify for reserve retirement, as you were advised to do in the 26 August 1976 letter, the Board concluded that a correction to your record was not warranted.

Accordingly, your application has been denied. The names and votes of the members of the panel will be furnished upon request.

It is regretted that the circumstances of your case are such that favorable action cannot be taken. You are entitled to have the Board reconsider its decision upon submission of new and material evidence or other matter not previously considered by the Board. In this regard, it is important to keep in mind that a presumption of regularity attaches to all official records. Consequently, when applying for a correction of an official naval record, the burden is on the applicant to demonstrate the existence of probable material error or injustice.
