



Dear

This is in reference to your application for correction of your naval record pursuant to the provisions of Title 10, United States Code, Section 1552.

A three-member panel of the Board for Correction of Naval Records, sitting in executive session, considered your application on 12 September 2001. Your allegations of error and injustice were reviewed in accordance with administrative regulations and procedures applicable to the proceedings of this Board. Documentary material considered by the Board consisted of your application, together with all material submitted in support thereof, your naval record and applicable statutes, regulations and policies.

After careful and conscientious consideration of the entire record, the Board found that the evidence submitted was insufficient to establish the existence of probable material error or injustice.

The Board found that you enlisted in the Navy on 11 December 1951 at age 17. The record reflects that you received nonjudicial punishment and were convicted by a special court-martial. The offenses included an unauthorized absence of 29 days, failure to report for hard labor, possession of clothing of other Sailors, and theft of clothing from other Sailors.

A second special court-martial convened on 20 August 1953 and found you guilty of possession of clothing belonging to four other Sailors. The court sentenced you to confinement at hard labor for three months and a bad conduct discharge. Subsequently, on 22 October 1953 you received a second nonjudicial punishment for writing pornographic literature. You received the bad conduct discharge on 11 December 1953.

In its review of your application the Board carefully weighed all potentially mitigating factors, such as your youth and immaturity. However, the Board concluded that these factors were not sufficient to warrant recharacterization of your discharge

due to the fact that during a period of two years, you were the subject of five disciplinary actions. Along these lines, the Board also noted that your offenses included theft and writing pornography. Based on the foregoing, the Board concluded that no change to the discharge is warranted. Accordingly, your application has been denied. The names and votes of the members of the panel will be furnished upon request.

It is regretted that the circumstances of your case are such that favorable action cannot be taken. You are entitled to have the Board reconsider its decision upon submission of new and material evidence or other matter not previously considered by the Board. In this regard, it is important to keep in mind that a presumption of regularity attaches to all official records. Consequently, when applying for a correction of an official naval record, the burden is on the applicant to demonstrate the existence of probable material error or injustice.
