- 1. Pursuant to the provisions of reference (a), Subject hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show she is entitled to be reimbursed for lodging expense while on Temporary Additional Duty (TAD) to Naval Air Station Brunswick, ME.
- 2. The Board, consisting of Messrs. Novello, Pfeiffer, and Taylor, reviewed Petitioner's allegations of error and injustice on 6 November 2001 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
- b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

## **CONCLUSION**

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

## **RECOMMENDATION:**

That Petitioner's naval record be corrected, where appropriate, to show that:

- a. On 29 May 2000 the orders which originally sent Petitioner on permissive TAD to Naval Air Station Brunswick, ME were modified to include the funding citation to authorize Petitioner to be reimbursed for lodging expense. Based on the modification to the orders Petitioner will be reimbursed in the amount of \$344.00 which was the cost of lodging for 32 nights at \$7.00 per night and for 12 nights at \$10.00. Petitioner will be reimbursed for lodging only and no other expenses.
  - b. That a copy of this Report of Proceedings be filed in Petitioner's naval record.
- 4. Pursuant to Section 6(c) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(c)) it is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
