- 1. Pursuant to the provisions of reference (a), Subject hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show the orders which transferred him to the Fleet Reserve were issued 22 August 2000.
- 2. The Board, consisting of Messrs. Novello, Pfeiffer, and Taylor, reviewed Petitioner's allegations of error and injustice on 6 November 2001 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
- b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

- a. The orders which transferred Petitioner to the Fleet Reserve were issued on "22 August 2000" vice any other date.
- b. On 24 August 2000 Petitioner executed the appropriate documents whereby he voluntarily elected to participate in the Do-It-Yourself (DITY) Program to move his HHGs; that by endorsement dated 25 August 2000 authority for him to participate in the DITY program was granted by the appropriate authorities and the proper documents were prepared to show that government procured equipment for the DITY move was obtained through the appropriate naval authorities and used by the Petitioner vice that he personally obtained and used rental equipment. (NOTE: Petitioner will forward a copy of this action and a copy of receipts and any paperwork he has pertaining to his move to the Naval Transportation Support Center, Personal Property Audit Division, 1667 Piersey Street Code, Norfolk, VA 23511-2806.)
- c. In the event Petitioner did not obtain weight tickets the incentive allowance will be based on the weight capacity of the rental truck(s).
 - d. That a copy of this Report of Proceedings be filed in Petitioner's naval record.
- 4. Pursuant to Section 6(c) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(c)) it is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
