- 1. Pursuant to the provisions of reference (a), Petitioner, a former enlisted member of the United States Marine Corps Reserve filed an application with this Board requesting that his record be corrected to show that he transferred to the Retired Reserve vice being discharged on 13 November 1998.
- 2. The Board, consisting of Mr. Novello, Mr. Taylor and Mr. Pfeiffer, reviewed Petitioner's allegations of error and injustice on 6 November 2001 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
 - Petitioner's application was filed in a timely manner.
- c. Petitioner reenlisted in the Marine Corps Reserve for six years on 14 November 1992. The Career Retired Credit Report (CRCR) shows that at the end of his anniversary year, on 4 November 1996, he was credited with 20 years of qualifying service for reserve retirement. On 1 January 1997 he was promoted to MSGT (E-8). About 10 months later, on 17 October 1997, he transferred to the individual ready reserve (IRR). Subsequently, he was issued a Notification of Eligibility for Retired Pay at Age 60. He was honorably discharged on 13 November 1998 at the expiration of his enlistment.
- d. On 27 June 2001, Headquarters Marine Corps (HQMC) informed Petitioner that although he was eligible for retired pay

at age 60, he had to petition the Board to correct the record to show that he was retired vice discharged. The Board did not request a further advisory opinion in this case. However, the Board is aware that Headquarters Marine Corps has routinely recommended corrective action in similar cases when an individual is qualified for reserve retirement an there is no explanation in the record why he was discharged and not retired.

- e. The Board is aware that an individual must earn two qualifying years after being promoted to retire in the higher grade. An indicated, the record shows that Petitioner only earned one partial qualifying year after being promoted to MSGT.
- f. The Board is aware that the Uniform Retirement Date Act, 5 U.S.C. 8301, requires that the effective date of any retirement be the first day of the month.

CONCLUSION:

Upon review and consideration of all the evidence of record the Board concludes that Petitioner's request warrants favorable action. The Board notes that Petitioner was in good standing in the Marine Corps Reserve and would have been retired if he had requested it. Therefore, the Board concludes that he should be transferred to the Retired Reserve. Given the requirements of the Uniform Retirement Date Act, the retirement should be effective on 1 November 1998, vice the discharge of 13 November 1998 now of record.

Concerning the issue of Petitioner's grade on retirement, the Board notes that he has not met the requirement to earn two qualifying years after being promoted. Therefore, the Board concludes that he should be transferred to the Retired Reserve in the grade of GYSGT (E-7). If he has evidence that he actually earned two qualifying years, then HQMC can correct the retirement point record and retire him as a MSGT. If he cannot establish additional qualifying years but believes that an error or injustice has occurred, he can submit an application to the Board on the issue of his grade on retirement.

The Board further concludes that this Report of Proceedings should be filed in Petitioner's naval record so that all future reviewers will understand his status in the Retired Reserve.

RECOMMENDATION:

a. That Petitioner's naval record be corrected to show that he transferred to the Retired Reserve on 1 November 1998 in the grade of GYSGT, or higher grade as determined by HQMC, vice being discharged on 13 November 1998.

- b. That this Report of Proceedings be filed in Petitioner's naval record.
- 4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
