REVIEW OF NAVAL RECORD

- 1. Pursuant to the provisions of reference (a), Subject hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show Petitioner was enrolled in the TRICARE Family Member Dental Plan (TFMDP) and his dependents were entitled to dental care under the TFMDP.
- The Board, consisting of Messrs. McPartlin, Pfeiffer, and Ms. Hare, reviewed Petitioner's allegations of error and injustice on 10 September 2002 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
- Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
- b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

- a. Petitioner was enrolled in the Tricare Family Member Dental Plan (FMDP) effective 1 November 2000. Petitioner's dependents were entitled to dental coverage under this plan from the TRICARE/United Concordia Dental Plan. (NOTE: Premiums will be collected for the period 1 November 2000 through 30 November 2001. Once premiums have been paid United Concordia Dental Plan should file a supplemental voucher for payment for services rendered.)
 - b. That a copy of this Report of Proceedings be filed in Petitioner's naval record.
- 4. Pursuant to Section 6(c) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(c)) it is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
