1. Pursuant to the provisions of reference (a), Subject hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show that his Home of Record and correct mailing address is shown on all the documents which recalled him to active duty.

- 2. The Board, consisting of Messrs. McPartlin, Pfeiffer, and Ms. Hare, reviewed Petitioner's allegations of error and injustice on 10 September 2002 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
- Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
- b. After reviewing the correspondence attached as enclosure (2), the Board concluded that the request has merit and warrants favorable action.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

That Petitioner's naval record be corrected, where appropriate, to show that:

- a. BuPers Orders 0227 issued on 6 February 2002 was modified to show that the mailing address on the orders recalling Petitioner to active duty was changed to 2002 Western Any recall documents listing the HOR will reflect the HOR as
