1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to adjust his Career Retirement Credit Report (CRCR), Pay Entry Base Date (PEBD), date of rank as a captain, and Reserve retirement anniversary date to reflect service in the Air Force Reserve from 11 March 1999 to 25 October 2000. His CRCR has been adjusted (enclosure (2)), his original PEBD of 31 May 1989 will be restored (enclosure (3)), and his original anniversary date of 31 May has been restored (enclosure (2)).

2. The Board, consisting of Messrs. Caron, Cooper, and Geisler, reviewed Petitioner's allegations of error and injustice on 25 January 2002, and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (4), the Headquarters Marine Corps (HQMC) Promotion Branch (MMPR), the office with cognizance over the subject matter of Petitioner's request to change his date of rank, has commented to the effect that this request has merit and warrants favorable action. They recommended that his date of rank be

changed from 23 January 1996 to 1 July 1994, the date of rank he held on the date of his discharge from the Air Force Reserve.

c. In correspondence attached as enclosure (5), the HQMC Separation and Retirement Branch (MMSR-6) has commented to the effect that they concurred with the opinion at enclosure (4).

CONCLUSION:

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosures (4) and (5), the Board finds the existence of an injustice warranting the following corrective action.

# **RECOMMENDATION:**

a. That Petitioner's naval record be corrected, where appropriate, to show that when he was originally appointed on 26 October 2000 as a captain in the Marine Corps Reserve, he was assigned a date of rank of 1 July 1994, vice 23 January 1996; and that his lineal precedence be adjusted accordingly.

b. That any material or entries inconsistent with the Board's recommendation be corrected, removed or completely expunged from Petitioner's record and that no such entries or material be added to the record in the future.

c. That a copy of this Report of Proceedings be filed at an appropriate location in Petitioner's naval record, and that another copy of this report be returned to this Board, together with any material directed to be removed from Petitioner's record, for retention in a confidential file maintained for such purpose.

4. Pursuant to Section 6(c) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(c)) it is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.



1. We have reviewed references (a) and (b) provide the following comment Captain **Example 5** request for adjustment of Date of Rank (DOR) and Pay Entry Base Date (PEBD).

2. Captain Current DOR of 960123 was assigned by MMPR at the time of his reappointment (enclosure (1)) and was intended, as a matter of policy, to ensure appropriate seniority and competitiveness for selection amongst his peers. It is our opinion that the adjustment of Captain **Captain** DOR should be referred to MMPR for decision.

Captain current PEBD of 910302 was assigned by 3. this office (CMT) at the time of his reappointment (enclosure (2)). At that time, we did not have the benefit of the supporting documentation contained in reference (b) which shows Captain Captai Reserve. Based on that documentation, we conclude that his PEBD was incorrectly assigned. Captain PEBD will be administratively reassigned to his original date of 890531.


