This is in reference to your application for correction of your naval record pursuant to the provisions of title 10 of the United States Code, section 1552.

A three-member panel of the Board for Correction of Naval Records, sitting in executive session, considered your application on 17 September 2002. Your allegations of error and injustice were reviewed in accordance with administrative regulations and procedures applicable to the proceedings of this Board. Documentary material considered by the Board consisted of your application, together with all material submitted in support thereof, your naval record and applicable statutes, regulations and policies. In addition, the Board considered the advisory opinion furnished by NPC memorandum 1160 Ser 811/327 of 9 August 2002, a copy of which is attached.

After careful and conscientious consideration of the entire record, the Board found that the evidence submitted was insufficient to establish the existence of probable material error or injustice. In this connection, the Board substantially concurred with the comments contained in the advisory opinion. Accordingly, your application has been denied. The names and votes of the members of the panel will be furnished upon request.

It is regretted that the circumstances of your case are such that favorable action cannot be taken. You are entitled to have the Board reconsider its decision upon submission of new and material evidence or other matter not previously considered by the Board. In this regard, it is important to keep in mind that a presumption of regularity attaches to all official records. Consequently, when applying for a correction of an official naval record, the burden is on the applicant to demonstrate the existence of probable material error or injustice.

1. In response to reference (a), recommend disapproval to the petitioner's request.

- a. The petitioner discharged from Active Duty on 22 January 1999 after two years of Navy service. The petitioner's rate and paygrade was SWCN/E3 at time of discharge.
- b. The petitioner reenlisted for three years on 29 December 2000 with an guarantee to attend AMH "A" school.
- c. The petitioner requests to receive a broken service SRB entitlement for the SW(0000) rate offered in reference (b).
- d. Per reference (c), members with broken-service must be a petty officer in an SRB eligible rating/NEC. Designated strikers are not eligible for broken-service SRB.
- 2. In view of the above, recommend petitioner's record remain as is.
- 3. This is an advisory memorandum to reference (a) for the use by the Board for Correction of Naval Records (BCNR) only. Enclosure (1) is returned.
