- 1. Pursuant to the provisions of reference (a), Petitioner, a former enlisted member of the Navy, filed enclosure (1) with this Board requesting in effect, that the DD Form 214 and associated service record pages be corrected to show her current name and sex.
- 2. The Board, consisting of Messrs. Lippolis, Nicholson, and Dunne, reviewed Petitioner's allegations of error and injustice on 9 October 2002 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
- b. Although it appears that enclosure (1) was not filed in timely manner, it is in the interest of justice to waive the statute of limitations and review the application on its merits.
- c. Petitioner, who was then a male, enlisted in the Navy 17 February 1970 and then reenlisted on 4 August 1972. On 3 August 1978 he received an honorable discharge by reason of expiration of term of service.
- d. In support of her application, Petitioner has submitted a copy of a court order which reflects that she has changed her name from Glenn W. Sharp to Glenda L. Sharp.

e. In some situations, a former servicemember will be provided with a "Statement of Service". This document sets forth the individual's name, other identifying data, and the period of time the individual served on active duty in the Navy. Such a statement could be issued to Petitioner in her current name, and this statement of service would be added to the record.

## CONCLUSION:

Upon review and consideration of all the evidence of record, the Board concludes that Petitioner's request warrants partial relief. The Board believes that it would be appropriate to create a document that will show Petitioner's two periods of service with her present name and gender. The Statement of Service for Petitioner should set forth her current name and the ddates she served in the Navy. However, the Board also believes that a correction to Petitioner's DD Form 214, or any other parts of the service record, would be inappropriate since those records correctly show that a man named Glenn W. Sharp served in the Navy from 17 February 1970 to 3 August 1978. Accordingly, the Board believes that such a Statement of Service should be provided to Petitioner showing her current name and the period of service.

In view of the foregoing, the Board finds the existence of an injustice warranting the following corrective action.

## RECOMMENDATION:

- a. That a Statement of Service be prepared for Petitioner showing the time served in the Navy and her present name and gender.
- b. That a copy of the foregoing Statement of Service, be placed in Petitioner's naval record.
  - c. That no further relief be granted.
- d. That a copy of this Report of Proceedings be filed in Petitioner's naval record.
- 4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
