- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that his naval record be corrected to show that he was discharged for being not physically qualified for service, vice by reason of unsatisfactory participation.
- 2. The Board, consisting of Messrs. Cooper, Frankfurt and Pfeiffer, reviewed Petitioner's allegations of error and injustice on 9 January 2003 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
  - b. Enclosure (1) was filed in a timely manner.
- c. In correspondence attached as enclosure (2), the Director, Naval Reserve Personnel Administration Division, Navy Personnel Command, recommended that Petitioner's request be granted.

## CONCLUSION:

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

## **RECOMMENDATION:**

- a. That Petitioner's naval record be corrected to show that he was honorably discharged on 5 April 2001, by reason of being not physically qualified for service, vice under honorable conditions by reason of unsatisfactory performance.
  - b. That a copy of this Report of Proceedings be filed in Petitioner's naval record.
- 4. Pursuant to Section 6(c) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(c)) it is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
