REVIEW OF NAVAL RECORD

- 1. Pursuant to the provisions of reference (a), Subject's widow, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show enrollment in the Survivor Benefit Plan (SBP) for spouse coverage.
- 2. The Board, consisting of Messrs. Cooper, Frankfurt, and Washington, reviewed Petitioner's allegations of error and injustice on 28 May 2003 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
- b. Cases with similar situations have been presented and approved by both the Board and the Assistant Secretary of the Navy. After being apprised of this fact and reviewing the correspondence attached as enclosure (2), the present Board concludes that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Subject's naval record be corrected, where appropriate, to show that:

- a. He executed a timely written request for enrollment in SBP spouse coverage, at the full base amount, naming the state of the state o
 - b. Retroactive SBP costs will be deducted from Mrs. future benefits.
 - c. Chief Petty Officer died on 24 November 2002.
 - d. That a copy of this Report of Proceedings be filed in Petitioner's naval record.
