REVIEW OF NAVAL RECORD

1. Pursuant to the provisions of reference (a), Subject hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show an extension was granted to ship household goods (HHGs) at government expense incident to her discharge from active duty on 15 May 2002.

2. The Board, consisting of Messrs. Novello, Pfeiffer, and Ms. Nofziger, reviewed Petitioner's allegations of error and injustice on 23 April 2003 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. After reviewing the correspondence attached as enclosure (2), the Board concluded that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

a. On 29 October 2002, Petitioner submitted a letter to the appropriate naval authorities requesting her entitlement to ship HHGs at government expense incident to her discharge from active duty be extended. On 29 October 2002 the appropriate naval authorities approved her request for an extension and extended her entitlement for a period of 8 months. Authority to ship HHGs at government expense incident to her discharge from active duty will expire on 11 July 2003.

b. That a copy of this Report of Proceedings be filed in Petitioner's naval record.


