1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show that she elected to participate in the Montgomery GI Bill (MGIB) Program when first eligible.

2. The Board, consisting of Messrs. Pfeiffer, Dietrich, and Koman reviewed Petitioner's allegations of error and injustice on 3 October 2006 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Subject's naval record be corrected, where appropriate, to show that:

a. Petitioner's record reflect that she signed DD Form 2366 and elected the MGIB Program on 29 September 1999. (NOTE: Petitioner is responsible for the \$1,200 enrollment contribution).


b. Petitioner's DD Form 2366 dated 9 May 2006 is null and void.

c. Petitioner's Certificate of Release or Discharge from Active Duty (DD Form 214) be amended by DD Form 215, reflecting that she contributed to the MGIB program.

d. A copy of this Report of Proceedings be filed in Petitioner's naval record.


