1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show Petitioner was entitled to Basic Allowance for Housing (BAH) for the prior duty station.

2. The Board, consisting of Messrs. Beckett, Dunn, and Pfeiffer, reviewed Petitioner's allegations of error and injustice on 17 October 2006 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:


a. On 3 February 2004 NPC modified the orders that reassigned Petitioner from the STU MED DEPT OST NATNAVMEDCEN, [REDACTED] FORCE, [REDACTED] to delete the Permanent Change of Station funding citation. Petitioner was reassigned within the same geographical area and was not authorized travel of dependents or to ship household goods at government expense.

b. Petitioner was authorized BAH for her prior duty station effective [REDACTED]. The prior duty station was the STU MED DEPT OST NATNAVMEDCEN, [REDACTED].

c. A copy of this Report of Proceedings will be filed in Petitioner's naval record.


