1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that his naval record be corrected to show that his name was not removed from the Temporary Disability Retired List (TDRL).

2. The Board, consisting of Mses. [REDACTED] and [REDACTED] and Mr. [REDACTED], reviewed Petitioner's allegations of error and injustice on 12 March 2009 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2), the Commandant of the Marine Corps recommends that Petitioner's name be restored to the TDRL.

CONCLUSION:

Upon review and consideration of all the evidence of record, and

especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:


a. That Petitioner's naval record be corrected to show that his name was not removed from the Temporary Disability Retired List on 1 July 2007 and that he was not discharged from the Marine Corps.

b. That Petitioner be afforded a periodic physical examination as soon as practicable. Current address: 715 Old Mill Road, Apt G-1, Wyomissing PA 19610

c. That a copy of this Report of Proceedings be filed in Petitioner's naval record.
