1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to establish entitlement to a zone "A", "B", and "C" Selective Reenlistment Bonus (SRB).

2. The Board, consisting of Mr. Pfeiffer, Mr. Zsalman, and Mr. George, reviewed Petitioner's allegations of error and injustice on 11 May 2009 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

a. The Petitioner was discharged and reenlisted on 29/30 April 2001, vice on or about 1/2 April 2001. The term is 4 years.

b. This change will entitle the member to a zone "A" SRB with an award level of 5.0 for the FC rate. The Petitioner has been paid a zone "A" bonus previously. Please re-calculate bonus for possible monetary credit in accordance with reenlistment adjustment.

c. The Petitioner executed a 10 month NAVPERS 1070/621 extension agreement, operative on or about 30 April 2005.

d. The 38 month NAVPERS 1070/621 extension agreement, operative on or about 2 February 2006, is null and void.

e. The Petitioner was discharged on 28 April 2005 and reenlisted, on 29 April 2005. The term is 4 years.

f. This change will entitle the member to a zone "B" SRB with an award level of 2.0 for the FC rate.


g. The Petitioner was discharged on 1 March 2009 and reenlisted, on 2 March 2009. The term is 6 years.

h. This change will entitle the member to a zone "C" SRB with an award level of 1.0 for the FC/1136 rate/NEC. Remaining obligated service to 28 April 2009 will be deducted from SRB computation. Remaining obligated service beyond the 16 year active date will not be included in the SRB calculation. The Petitioner has been paid a zone "C" bonus previously. Please re-calculate bonus for possible monetary credit in accordance with previous reenlistment adjustment.

i. A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. Pursuant to Section 6(c) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(c)) it is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
