1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to establish entitlement to an Enlistment Bonus for College Credit (EBCC).

2. The Board, consisting of Messrs. George, Pfeiffer, and Zsalmán, reviewed Petitioner's allegations of error and injustice on 6 July 2009 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

a. Option (2) of Annex B to the DD Form 4 reflects "Enlistment Bonus - Source Rate \$36,000," vice "Enlistment Bonus - Source Rate \$40,000."

b. Option (3) of Annex B to the DD Form 4 reflects "Enlistment Bonus for College Credit (EBCC) - \$4,000," vice "N/A." All other enlistment guarantees remain the same.


c. The \$4,000 EBCC will be paid by the Defense Finance and Accounting Service (DFAS).

d. Upon successful completion of training the \$36,000 EBSR will be processed through the Navy Personnel Command (NPC) in accordance with applicable Enlistment Bonus payment procedures.

e. A copy of this Report of Proceedings will be filed in Petitioner's naval record.


4. It is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true complete record of the Board's proceedings in the above entitled matter.
