1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed written application, enclosure (1), with this Board requesting, in effect, that his naval record be corrected to show that he was on the Inactive Status List (ISL) from 1 June 2007 to 26 February 2008. He further requested removing his failure of selection by the Fiscal Year (FY) 2010 Reserve Major Selection Board, so as to be considered by the selection board next convened to consider officers of his category for promotion to major as an officer who has not failed of selection for promotion to that grade.

2. The Board, consisting of Messrs. Delorier, Pfeiffer and Rothlein, reviewed Petitioner's allegations of error and injustice on 6 August 2009, and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies which were available under existing law and regulations within the Department of the Navy.

b. In Petitioner's previous case, docket number 4960-07 (copy of Report of Proceedings at enclosure (2)), this Board directed, in part, correcting his record to show he was on the ISL from 18 December 2000 to 28 June 2007.

c. In correspondence at enclosure (3), the Headquarters Marine Corps office with cognizance over the subject matter of Petitioner's case has commented to the effect his application has merit and warrants favorable action.

CONCLUSION:

Upon review and consideration of all the evidence of record, and especially in light of enclosure (3), the Board finds an injustice warranting the following corrective action:

RECOMMENDATION:

a. That Petitioner's naval record be corrected to show he was on the ISL from 29 June 2007 to 26 February 2008.

b. That his record be corrected further so that he will be considered by the earliest possible selection board convened to consider officers of his category for promotion to major as an officer who has not failed of selection for promotion to that grade.


c. That any material or entries inconsistent with or relating to the Board's recommendation be corrected, removed or completely expunged from Petitioner's record and that no such entries be added to the record in the future.

d. That any material directed to be removed from Petitioner's naval record be returned to the Board, together with a copy of this Report of Proceedings, for retention in a confidential file maintained for such purpose, with no cross reference being made a part of Petitioner's naval record.


