1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, requests correction of her record as indicated in enclosure (1).

2. The Board, consisting of Messrs. [REDACTED], [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 23 September 2010 and, pursuant to its regulations, determined that the action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. Enclosure (1) was filed in a timely manner, or it is in the interest of justice to excuse Petitioner's failure to file enclosure (1) in a timely manner.

b. Petitioner's case is within the category of cases covered by reference (b).

CONCLUSION:

Upon review and consideration of all the evidence of record, and in accordance with the provisions of reference (b), the Board directs the corrective action indicated below.

As Petitioner's case has not been finalized by the Naval Disability Evaluation System (DES), her request for a final

rating of 50% for posttraumatic stress disorder is premature and was not considered by the Board. She may reapply to the Board after she has exhausted her administrative remedies within the DES.


RECOMMENDATION:

a. That Petitioner's naval record be corrected to show that she was assigned a disability rating of 50% for posttraumatic stress disorder when her name was placed on the Temporary Disability Retired List effective 1 October 2008, vice the rating of 30% she actually received on that date, provided that such action does not adversely affect her total compensation, including but not limited to combat-related special compensation.

b. That a copy of these proceedings be filed in her naval record.

4. Pursuant to Section 6(c) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(c)) it is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
