1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to modify the Petitioner's date of rank to Sergeant and to establish entitlement to a zone "A" bonus in the amount of \$18,900.

2. The Board, consisting of Mr. Pfeiffer, Mr. Zsalman, and Mr. Exnicios, reviewed Petitioner's allegations of error and injustice on 14 February 2011 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following partial corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

a. The Petitioner's date of rank to Sergeant is "12 November 2005" vice "14 January 2009".

b. That so much of Petitioner's request for corrective action as exceeds the foregoing be denied for the following reason: When he reenlisted on 14 January 2009, Petitioner had more than 6 and fewer than 10 years of prior active service. Accordingly, he was in bonus zone "B". He has already received the bonus amount properly authorized for zone "B". He is not entitled to a zone "A" bonus because he was not in zone "A."

c. A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
