1. Pursuant to the provisions of reference (a) Petitioner filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show he was automatically advance to E-4/IS3 on 4 March 2010, vice 16 July 2010, now of record, pursuant the New Accession Training (NAT) program based on his enrollment in the Advanced Technical Field (ATF).

2. The Board, consisting of Messrs. Pfeiffer, Zsalman, and George reviewed Petitioner's allegations of error and injustice on 27 June 2011 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds

the existence of an injustice warranting the following corrective action.

RECOMMENDATION:


That Petitioner's naval record be corrected, where appropriate, as follows:

a. Petitioner was advanced to E-4/IS3 with an effective date of 4 March 2010, vice 16 July 2010, based on his enrollment in the ATF program and successful completion of petty officer indoctrination class.

b. That a copy of this Report of Proceedings be filed in Petitioner's naval record.
