1. Pursuant to the provisions of reference (a) Petitioner filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show that his obligated service date is June 2016 vice July 2020.
2. The Board, consisting of Messrs. Zsalman, Ruskin and George, reviewed Petitioner's allegations of error and injustice on 11 August 2014 and, pursuant to its regulations, determined that the partial corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
  - a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
  - b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that Petitioner's request warrants partial relief as described below.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds

the existence of an injustice warranting the following partial corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, as follows:


a. Petitioner's service record is corrected to show an Obligated Service Date of March 2017 vice July 2020, now of record.

b. That so much of Petitioner's request for corrective action as exceeds the foregoing be denied.

c. A copy of this Report of Proceedings be filed in Petitioner's naval record.
