1. Pursuant to the provisions of reference (a) Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show that he had one additional award point that should have been added to the March 2013 Navy-wide advancement exam. Additionally, Petitioner requests to be advanced to E-5 from the March 2013 Navy-wide advancement exam.

2. The Board, consisting of Messrs. Zsalman, Ruskin and Exnicios reviewed Petitioner's allegations of error and injustice on 21 July 2014 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, as follows:

a. Petitioner was advanced to E-5/ABE2 from the March 2013 Navy-wide advancement exam with an effective date of 16 December 2013 with a Time In Rate date of 1 July 2013.


Note: One award point for a Flag Letter of Commendation was administratively resolved by Petitioner's command.

b. Petitioner is authorized all back pay and allowances from the effective date forward.

c. A copy of this Report of Proceedings will be filed in Petitioner's naval record.


