1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show Petitioner's agreement to extend enlistment in the Inactive Manpower and Personnel Management Information System (IMAPMIS).

2. The Board, consisting of [REDACTED] reviewed Petitioner's allegations of error and injustice on 1 December 2014 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

a. Note: the Petitioner executed a 24 month agreement to extend enlistment (NAVPERS 1070/621), on or about 15 May 2012.


b. Note: the Petitioner executed a 4 month agreement to extend enlistment (NAVPERS 1070/621), on or about 15 May 2014.

c. This will establish in the Inactive Manpower and Personnel Management Information System (IMAPMIS) an Expiration of Obligated Service (EOS) of 19 September 2014.

d. Note: Petitioner transferred to the Retired Reserve Status with Pay effective 23 May 2014.


e. A copy of this Report of Proceedings will be filed in Petitioner's naval record.
