1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to modify a certificate of release or discharge from active duty.

2. The Board, consisting of [REDACTED] reviewed Petitioner's allegations of error and injustice on 20 January 2015 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:


That Petitioner's naval record be corrected, where appropriate, to show that:

a. The certificate of release or discharge from active duty (DD Form 214, Aug 2009), executed on or about 28 August 2011, is modified to read block 18 (Remarks) "BLK 14 CONT: INTER-SERVICE CONSTRUCTION MECHANIC APPRENTICE, 13WKS, NOV03. SERIAL NUMBER: 43146-11-0702-JDB.\\\" vice "DISABILITY SEVERANCE PAY AUTHORIZED AND PAID IN AMOUNT OF \$49,919.25. BLK 14 CONT: INTER-SERVICE CONSTRUCTION MECHANIC APPRENTICE, 13WKS, NOV03. SERIAL NUMBER: 43146-11-0702-JDB.\\\", block 23 (Type of Separation) "Temporary Physical Disability (TDRL)" vice "DISCHARGE", block 25 (Separation Authority) "MILPERSMAN 1850-020, CNPC DTG 030027Z AUG 11" vice "MILPERSMAN 1910-104", and block 28 (Narrative Reason For Separation) "DISABILITY, TEMPORARY" vice "DISABILITY, SEVERANCE PAY NON COMBAT".

b. Note: any payment of severance pay will be deducted from Petitioner's benefits. No waiver will be granted.


c. A copy of this Report of Proceedings will be filed in Petitioner's naval record.
