- 1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to modify an immediate reenlistment contract.
- 2. The Board, consisting of reviewed Petitioner's allegations of error and injustice on 23 February 2015 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
- b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

- a. The C year Immediate Reenlistment Contract (NAVPERS 1070/601), executed on or about 11 June 2014, is modified to read "Naval Reserve" vice "United States Navy", BR/CL "USNR" vice "USN", and RADO MONTHS/DAYS "072/000", vice "000/000". The Enlistment Master File (EMF) should reflect BRCL "32", SPI-TAR "V", TAR-TEMAC "Y", EAOS "10 June 2020", SEAOS "10 June 2020", RADOMO "072", and EREN "10 June 2020".
- b. A copy of this Report of Proceedings will be filed in Petitioner's naval record.
- 4. It is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)) and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taker under the authority of reference (a), has been approved by the Board on behalf of the Secretary of the Navv.
